In addition, Field visits were also organized to various places like Muhana, Wholesale Market of Jaipur, Rajasthan Olive Cultivation Limited, Barefoot college to understand the value chain and innovation in Agricultural Marketing.

Production of Ethanol directly from Bmolasses or Sugarcane Juice


India , the second largest producer of sugar in the world ,but the sugar mills remain burdened with losses due to a heavy supply glut in the market.

Government of India , through The sugarcane control order of 1966 has allowed the conversion of sugarcane juice or B-molasses directly into ethanol, a major biofuel . This will help the sugar mills to handle the excessive cane supply which would otherwise create surplus sugar leading to low sugar prices and heavy loss to the sugar mills. Before this, the mills were allowed to produce ethanol from C-molasses, left after the complete removal of sucrose during the production of sugar.

Ethanol is in major demand by the oil industries for blending it with petrol. Moreover, OMCs procure ethanol from sugar mills. The price of ethanol produced from C-molasses is Rs 43.70 per liter whereas the one produced by

B-molasses has a price of Rs 47.49 per liter. Thus, there will be an increase in the ethanol availability and the sugar mills would be able to recover their losses.

India's massive milk glut to hit international prices


India is the largest producer of milk valued at 165.4 MMT in FY17, and its value is more than that of rice and wheat combined. So, it is India's biggest agri-produce and it is largely grown by small and landless agrihouseholds, employing more than 70% women. The country's milk production has grown at a compound annual rate of 4.9% over the last decade and is expected to reach a record 180 MMT this fiscal year. But, the Indian Dairy Market, especially the Skimmed Milk Powder Market might have reached a saturation point. With around 400,000 tonnes of SMP in reserves in various private dairies, the milk prices have been falling continuously. Due to this reason, the recent farmer protests in the states of Maharashtra and Gujarat took place. Raw milk prices have fallen by 20-25% in the last 18 months. India has not had a huge impact on the dried milk export market, but with the government subsidies and support, that gap is going to get narrowed. The biggest exporters New Zealand and the United States have shown huge concerns as prices have already slumped down to \$1550/tonnes and the road to recovery is not easy.



Implementation of Bio-fuel policy

Someone rightly said, "If we keep pulling death from the ground, we will reap death from the skies." We have been pulling death from the ground in the form of fossil fuels since ages. The World is fighting for fuel. Our dependence on Fossil fuels is such that it's hard to imagine life without petroleum, coal and their derivatives. But the harsh reality is- They are diminishing. The fossil fuel reserves are depleting at an alarming rate.

Bio-fuels such as bio-diesel and ethanol are gaining world-wide acceptance as a solution for problems of environmental degradation, energy security, restricting imports, rural employment and agricultural economy. Hence, our government has taken an initiative to switch to biofuels. A detailed policy has been framed and steps are being taken in this direction. There are around 400 species of trees bearing non-edible oil seeds for example Neem, Jojoba, Karanja, Mahua, Wild Apricot, Jatropha, Cheura, Kokum, Tung & Olive. The government has already proposed that plantation of such trees will be done on government/community waste-land so that agricultural land is not wasted. MSP would be ensured for farmers undertaking such plantations.

Import of biofuels would only be permitted to the extent necessary and will be decided by the National Biofuel Coordination Committee proposed under this Policy.

Recently, on 1st August 2018, Rajasthan became the first state to implement biofuel policy. Biofuels are the best alternative so far for fossil fuels. Hence, correct implementation and promotion of biofuel policy will play a vital role in shaping Indian economy

"Rythu Bandhu scheme "- Farmers fruit basket

Telangana's 'Rythu Bandhu' scheme is to support farmers' investment for two crops a year. The government is providing 5.83 million farmers Rs 4,000 per acre per season to support farm investment twice a year, for the Rabi and Kharif seasons for buying seed, fertilizers, and pesticides. The RBI has already released a 95 percent money budget for the scheme which is aimed at breaking the vicious cycle of rural indebtedness. Every farmer has issued a 'Pattadar Dharani' passbook, a replacement for all other farm ownership documents. Linked to Aadhaar, it eliminates the possibility of middlemen eating into farmers' benefits. The Telangana CM has appealed to well-off farmers to voluntarily give up claim to the scheme. This scheme is vastly different from any loan waiver scheme wherein the farmers take loans from a lending institution and when unable to repay are bailed out by the government, as in Punjab and Haryana. But 'Rythu Bandhu' provides funds to farmers ahead of sowing so that they do not have to bother about input costs. However, the money goes to big landlords who may not need help, while "real cultivators" may be left out. Further to improve the scheme it's suggested to remove paddy and wheat from the investment support scheme and dealing with them under the procurement scheme, which will reduce the cost significantly. By doing so, the farmer may opt for

crop diversification by allocating more area to cash crops.

Liquid Nano Clay

Water is a scarce resource which many of us take granted. Farmers in UAE, those who grow in oasis' know how much water they have to buy in order to do farming almost thrice the normally required. Since droughts, intensive farming, erosion and deforestation they are converting arable land into deserts. Hence can we consider farming practice in UAE as the future of our farming?

According to the United Nations, by 2030 more than 135 million people could lose their homes and livelihood due to desertification. to fight this battle with desertification a Norway based company Desert Control has patented a very innovative technology which gives sand particles nanostructured clay coating. They called it Liquid Nano Clay (LNC), it can increase the yield from same soil more than three to four times with half the amount of water they used earlier. Cost of treatment per hectare is \$4800. According to Ole Morten co-founder Desert Control "in just seven hours the soil is totally transformed". Companies motto also comes inline to its objective- It's time to rejuvenate, the planet.
